3. What study plan do you want to use?

For this question it's important to consider how much time you have to prepare for the Patent Bar exam each week. If you are in a situation where you have a deadline then use the details below to gauge how much time you'll need to study each week.

*The majority of the clients I speak with use the 3 or 6 month plan (we provide them in full detail in the complete course), but any of these plan are possibilities for you. Please be sure you actually have the time available along with the willingness to spend the required amount of study time before you commit to one of the shorter plans.

Study Plan Options:

<u>1 Month</u> *	<u>2 Months</u>
7 days per week	5 to 6 days per week
30 to 50+ hours of weekly study	20 to 35 hours of weekly study

* The 1 month plan is not ideal. We have only heard from a handful of past clients who were actually able to pass the Patent Bar with this limited amount of time. You would need to have a very open schedule because you will need to spend all day studying. Even if you do have the time available please realize that not everyone will be able to keep up with the required pace and get through enough of the content and practice questions to pass.

<u>3 Months</u>	<u>6 Months</u>
4 to 5 days per week	3 to 4 days per week
10 to 25 hours of study per week	5 to 15 hours of study per week

<u>9 Months</u>	<u>12 Months</u> *
3 (sometimes 4) days per week	2 (sometimes 3) days per week
4 to 10 hours of weekly study	3 to 6 hours of weekly study

*Many people wind up spending a whole year preparing for the exam which is fine, however you will need to invest more time on a final review. We suggest spending 1 month on your final review in our 12-month study plan because you may not be able to retain the information over the entire year. A shorter study plan like the 3 month plan will require you to retain the information over a much shorter length of time therefore you'll need less time for a final review. The main point to make is with a more extended study plan like a 12 month plan you will need to review much of the material more than once. It's important to factor that into your decision
